**Note 1:** Key First Nation membership codes have come into effect September, 1987.

The following excerpts of sections and subsections of the Key First Nation Membership Code define who is eligible for the Key First Nation membership.

**Section 8** – The following persons are entitled to membership with the Key First Nation.

- a. The original (existing, present) members and those who were entitled to be members of the Key First Nation prior to April 17, 1985.
- b. The natural and adopted child or children of parents who were entitled to be member(s), of the Key First Nation under clause 8 (a)
- c. Persons entitled to membership as a result of reinstatement by which they automatically received membership under amendments to the Indian Act, June 28, 1985.
- d. Such other persons as the Key First Nation may be determined from time to time upon application to the Chief and Council.

**Section 9** – A person who is a member of another Band is entitled to apply to the Chief and Council for the purposes of being entered on to the Band list.

**NOTE 2:** Section 8c.....Amendments to the Indian Act June 28, 1985.

**NOTE 3:** All applicants over 18 years must apply on their own behalf.

**NOTE 5:** Section 10 (4) for acquired rights

Membership rules established by a band under this section may not deprive any person who had the right to have his name entered in the Band List for that band, immediately prior to the time rules were established, of the right to have his name so entered by reason only of a solution that existed or an action that was taken before the rules came into force.

# MEMBERSHIP CODE OF THE KEY FIRST NATION

We, the peoples of the Key First Nation of Indians, in order that our inherent, treaty and other rights and freedoms are fully protected, exercised and enhanced to ensure justice and our security; to maintain Saulteaux traditions and customs; and to promote harmony and the common good, state the following:

1. We, the peoples of the Key First Nation do not accept, by the act of adopting this Membership Code, and diminishment of our sovereign status as a nation and of our vested and inherent rights, as confirmed by the Royal Proclamation of 1763, the Canada Act, 1982 and by our forefathers under the treaties.
2. The Key First Nation shall adopt, ordain and establish this Membership Code.
3. This Membership Code shall determine who members of the Key First Nation are.
4. This Membership Code shall be adopted by a majority of the electors of the Key First Nation.
5. This Membership Code can be amended or repealed by a majority of the electors upon review every 6 months.
6. The Key First Nation has given the Chief and Council the power to determine membership under provisions of the Code.
7. The Key First Nation shall establish a Review Committee (Elders, Judge, or Peacemaker) to review membership decisions, with powers to adjust, suspend or reverse decisions, whose decision must be ratified by majority of the Key First Nation electors.
8. The following persons are entitled to Membership in the Key First Nation
  - a) The Original (existing, present) Members, and those who were entitled to be Members of the Key First Nation, prior to April 17, 1985;
  - b) The natural and adopted child or children or parents who are member (s) or entitled to be Member (s), of the Key First Nation under clause 8 (a).
  - c) Persons entitled to Membership as a result to reinstatement by which they automatically received membership under amendments to the Indian Act, June 28, 1985;
  - d) Such other persons as the Key First Nation may be determined from time to time upon application to the Chief and Council.
9. A person who is a member of another First Nation is entitled to apply to the Chief and Council for the purposes of being entered on the band list.
